

CONSULATE GENERAL OF SAINT LUCIA

CHANGE OF PARTICULARS FORM

Saint Lucian nationals applying for a Saint Lucian passport should complete a Change of Particulars Form if they are already registered with an NIC number and any of the following applies:

- 1. Applicant is a woman and her marital status has changed (form must be completed even if the applicant is not going to use her husband's surname).
- 2. Applicant is a married woman and wishes to use her husband's surname.
- 3. Applicant is a divorced/widowed woman and wishes to revert to her maiden name (name at birth).
- 4. Applicant's name on birth certificate is different from applicant's name (applies to either Christian names and/or Surname) on old NIC card or Saint Lucia National identification card. This would include spelling errors and omissions.
- 5. Applicant's date of birth on birth certificate is different from applicant's date of birth on old NIC card or Saint Lucia National identification card.
- 6. Applicants has a legal name change.

Documents required to submit a Change of Particulars Form (No copies allowed. Original documents must be provided):

- Saint Lucia birth certificate
- Saint Lucian passport
- Marriage Certificate (married women and divorced women only)
- Divorce Certificate (divorced women only)
- Death Certificate (widowed women only)
- Deed Poll/Change of Name document (persons who have legally changed their name)
- NIC card (if available)
- Saint Lucia national ID card/Saint Lucian Driver's licence (if available)

NOTE: Other documents may be required if requested by NIC.

DATE:	Enter Date completing the form (Format: DD/MM/YYYY).	
NI #:	Enter NIC number, if known. If unknown, please leave blank.	
NAME (PREVIOUS):	Married women who want to use their husband's surname, enter name at birth.	
	Divorced/widowed women who want to revert to maiden name, enter married name.	
	Applicants whose name is incorrectly registered at NIC, enter the name registered at NIC.	
	Applicants who have a legal name change, enter name used before the change of name.	
	Format of Name: Enter christian names (s) then enter Last Name (Surname)	
NEW NAME:	Married women who want to use spouse's name enter, christian name(s) and new surname.	
	Divorced/widowed women who want to revert to maiden name, enter christian name(s) and	
	surname at birth.	
	Corrections (Spelling errors and/or omissions), enter correct name.	
	Applicants who have changed their name, enter their new name (on Deed Poll or Change of	
	Name document).	
	Format of Name: Enter christian names (s) then enter Last Name (Surname)	
SPOUSE NAME:	If Married, enter Spouse's name	
	Format of Name: Enter spouse's christian names (s) then enter Last Name (Surname)	
	If not married, enter N/A (not applicable).	
DATE OF MARRIAGE:	If Married, enter Date of Marriage (Format: DD/MM/YYYY).	
	If not married, enter N/A (not applicable).	
DATE OF BIRTH (OLD):	Enter your Date of Birth (Format: DD/MM/YYYY).	
	For applicants who are correcting their date of birth, enter Incorrect date of birth (Format: DD/MM/YYYY)	
DATE OF BIRTH (NEW):	Only complete if there is a correction to date of birth.	
	For applicants who are correcting their date of birth, enter correct date of birth (Format: DD/MM/YYYY).	
	If there is no correction to date of birth, enter N/A (not applicable).	
ADDRESS:	Enter current address in Canada (include apartment # (if applicable), City,	
	Province and Postal Code.	
TELEPHONE:	Enter current telephone number (in Canada).	
Yours Faithfully:	Enter Signature under Yours Faithfully.	
Witness:	Do Not Complete. Consulate officer will sign as applicant's witness.
